

NOTICE IS HEREBY GIVEN that, in accordance with the provisions of the Uniform District Election Law of the State of California, a General District Election may be held on Tuesday, November 4, 2025, for the office of District Director in the following special districts located in Sonoma County:

Declarations of Candidacy for eligible candidates desiring to file for any of the above offices may be obtained from the Registrar of Voters Office, 435 Fiscal Dr, Santa Rosa, CA, on or after July 14, 2025, and completed no later than 5pm on August 8, 2025. If an incumbent officeholder has not filed by this time, their seat goes into extension and potential candidates shall have until 5pm on August 13, 2025, to file their paperwork.

In the event there are no nominees or, an insufficient number of nominees for the office, and a petition for an election is not filed with the election official within the time period prescribed by Elections Code § 10515 for special districts (by 5pm on August 13), the supervising authority will make appointments to each elective office. In the event that the number of nominees equals the number of seats to be filled in a given district, that district will not go to election, and the nominees shall be sworn in.

Ballots for the November 4, 2025, election will be sent to every active registered voter beginning October 6, 2025. See the Sonoma County Registrar of Voters website, SoCoVotes.com, for more information.

En el caso de que el número de nominados sea igual al número de cargos a cubrir en un distrito determinado, ese distrito no irá a elección y los nominados prestarán juramento.
